8. DESCRIPTION OF NATIONAL HIGHER EDUCATION SYSTEM

8.1. Access to the higher education

The total duration of education until completion of a school which offers the possibility of taking the secondary school leaving examination (maturity examination) is 12 and 15 years. Having passed successfully the secondary school leaving examination (maturity examination), graduates are awarded a secondary school leaving certificate which entitles them to apply for admission to a higher education institution.

8.2. Higher education system

Higher education system in Poland and the basis for its operation are laid down in the Act of 20 July 2018 – Law on Higher Education and Science (Journal of Laws, item 1668, as amended).

Public higher education institutions are established by state authorities. Courses of study may be conducted as first or second-cycle programmes or uniform Master's degree programmes. Courses of study may be conducted as full-time and part-time programmes.

Full-time first-cycle programmes last at least 6 semesters and in if study syllabus includes educational outcomes which lead to obtaining engineering skills – at least 7 semesters. Full-time second-cycle programmes last from 3 to 5 semesters. Full-time uniform Master's degree programmes last from 9 to 12 semesters.

Part-time programmes may last longer than the corresponding full-time programmes.

Polish Qualifications Framework level specified in the Act of 22 December 2015 on Integrated Qualifications System (Journal of Laws of 2018, item 2153, as amended) is allocated to the qualification awarded on completion of a course of study.

Diploma of completion of first-cycle programme confirms conferment of full qualification at Polish Qualifications Framework level six.

Diploma of completion of second-cycle programme and diploma of completion of uniform Master's degree programme confirm conferment of full qualification at Polish Qualifications Framework level seven.

8.3. Degrees awarded to graduates of higher education institutions:

1) licencjat (*Bachelor*), inżynier (*Engineer*) and equivalent degrees: inżynier architekt (*Engineer Architect*), inżynier pożarnictwa (*Bachelor's Degree in Fire Protection Engineering*), licencjat pielęgniarstwa (*Bachelor's Degree in Nursing*), licencjat położnictwa (*Bachelor's Degree in Obstetrics*) – are awarded to graduates of first-cycle programmes,

2) magister (*Master*) and magister inżynier (*Master Engineer*) and equivalent degrees:

a) magister inżynier architekt (*Master of Science Civil Engineer Architect*), magister inżynier pożarnictwa (*Master of Science Fire Protection Engineer*), magister pielęgniarstwa (*Master of Science in Nursing*), magister położnictwa (*Master of Science in Obstetrics*) – are awarded to graduates of second-cycle programmes,

b) lekarz (*Physician*), lekarz dentyista (*Dental Surgeon*), lekarz weterynarii (*Veterinarian*), magister farmacji (*Master of Pharmacy*), magister inżynier architekt (*Master of Science Civil Engineer Architect*) – are awarded to graduates of uniform Master's degree programmes.

8.4. Credit points

To be awarded a diploma a student is obliged to gather at least 180 ECTS credits upon completion of a first-cycle programme, at least 90 ECTS credits upon completion of a second-cycle programme, at least 300 ECTS credits upon completion of a uniform Master's degree programme lasting 9 or 10 semesters, or at least 360 ECTS credits upon completion of a uniform Master's degree programme lasting 11 or 12 semesters.
